Serve as the Chief Executive Officer (CEO) responsible for providing executive level leadership, vision and guidance to the organization, providing recommendations to the City Commission and implementing policy directives in an efficient and effective manner – all part of an incredibly diverse and dynamic community. Currently, serving as the 2nd longest serving City Manager in Miami Beach history. Have made some significant contributions to ensure the City's position as a world-class destination, while confronting the challenges of managing and servicing approximately 90,000 residents, along with an average daily population of 200,000-300,000 visitors.

- Developed and implemented the City's strategic planning framework, establishing a formal planning process and fostering an organizational culture focused on teamwork, performance measurement, effectiveness and out-of the box thinking.
- Successfully negotiated to make the City of Miami Beach the home of Art Basel Miami Beach, the sister event of the world's most prestigious art show, Art Basel. Today, the City hosts the most important art show in the Western Hemisphere, bringing an exclusive selection of more than 250 leading art galleries from North America, Latin America, Europe, Asia and Africa to exhibit 20th and 21st century artworks by over 2,000 artists.
- Instrumental in attracting and promoting high-profile special events for the destination, ranging from Super Bowl (2007 and 2010), the Food Network's South Beach Food & Wine Festival, the Latin Grammys, MTV Latin Music Awards, the SOURCE Awards, and the Latin Billboard Awards. As a result, the City of Miami Beach enjoys a reputation as a trend-setting destination.
- Successfully negotiated and entered into a joint development agreement with the New World Symphony to develop a six acre site, consisting of a symphony building, a public garage and City park designed by world-renowned architect Frank O. Gehry, with a total construction value in excess of \$200 million.
- Negotiated with the two top producers of live music, AEG and Live Nation, and a world renowned brand, Cirque du Soleil, competing to use and manage the Jackie Gleason Theater. In 2007, successfully negotiated a management agreement with Live Nation, considered the world's largest producer of live music, which brings the City over \$1 million in distributed proceeds, through the re-branded, the Fillmore Miami Beach at the Jackie Gleason Theater.
- In 2003, led the City's efforts which resulted in the City of Miami Beach receiving the "All America City" Award from the National Civic League, making Miami Beach the only community in the state of Florida and only one of ten from around the country, to receive this prestigious, national award at the time.
- Drives a culture of professional public management, gaining the accreditation of various City departments including: Public Works, Fire, Parks & Recreation and Police.
- Navigated the most challenging economic environment local government has faced in modern times, while maintaining the City's strong financial position securing two (2) bond rating upgrades to Moody's to AA2 – one spot away from the top rating – at a time when other local governments have seen their ratings affected by the ongoing slow economy and the condition of state and federal finances.
- Focus on the long term financial sustainability, including securing employee concessions from five (5) distinct bargaining unions and pension reform, maintaining the millage rate at historically low levels, adoption of financial policies that focus on the growth of fund reserves and reduction General Fund reliance on property tax revenue.

- Participated in statewide negotiation efforts to develop right-of-way (ROW) legislation to ensure local management and use and fees for the use of public rights-of-way, which resulted in approval of legislation which generates and estimated \$20 million for local governments annually; and served on VACo Telecommunications Policy Committee.
