ACADEMIC PROFESSIONAL EXPERIENCE

August 1990 to Present - Lecturer, Political Science Department, University of Miami, I teach nine courses per year. For 14 years, I was an academic advisor to half the freshmen Political Science majors at the University of Miami.

August 1988 to August 1990 - Associate Director, Institute of Government, Florida International University. I managed the Institute and supervised its staff. I wrote grant proposals, maintained program and financial records, and submitted periodic reports. I worked with FIU professors and outside consultants to deliver technical assistance,

consulting services, training, policy forums and executive leadership development programs to municipal, county and state administrators, appointees and elected officials in Miami-Dade, Broward and Monroe Counties. I prepared advertising material for IOG programs, and also organized all conferences, forums, meetings, seminars and training events.

August 1978 to August 1988 - Adjunct Professor, Political Science Department, University of Miami. While working full-time in non-academic positions, I taught Political Science part-time at UM.

NON-ACADEMIC PROFESSIONAL EXPERIENCE

August 1990 to December 1997 - Owner/Consultant, Thompson Communications. I contracted with public and private non-profit organizations in the Greater Miami area to do grant proposals, annual reports, brochures, newsletters, research, fundraising, media relations, speeches, advertising campaigns, and special event planning.

August 1984 to August 1988 - Director, Special Projects, Switchboard of Miami. I wrote grant proposals; produced written advertising material for the agency; did fundraising; coordinated special events; functioned as director on short-term federally-

funded projects; wrote reports; wrote speeches for others and delivered public testimony; wrote and placed PSAs; and served as the Executive Director's liaison to the Board of Directors, media, and community organizations.

July 1982 to July 1983 - Executive Director, American Civil Liberties Union of Florida and the ACLU of Florida Foundation. I managed state-wide operations of the ACLU; supervised the staff in the state headquarters in Miami, lobbyists in Tallahassee, and volunteers and attorneys throughout Florida; planned and conducted PR, advertising, fundraising, and membership campaigns; handled media contacts state-wide, doing interviews about the organization and pertinent cases; coordinated special events; worked with the Board to develop policy and procedures for the ACLU; and managed the financial operations of the organization.

February 1979 to July 1982 - Director, Community Affairs, Urban League of Greater Miami, Inc. I carried out public relations tasks; planned and conducted fundraising activities, membership campaigns, and special events; wrote public service announcements for radio and TV, speeches, position papers, annual reports, newsletters, press releases, and brochures; and served as liaison between the President's Office and the Board, media, and community.

February 1978 to February 1979 - City Desk Researcher, The Miami Herald. I did political and social research for investigative and urban affairs reporters on the City Desk. I wrote general assignment articles for the Local Section and for Tropic Magazine.

Grant Proposals

I've written approximately 40 grant proposals that were funded by the federal or state government over the years. These included:

Switchboard of Miami, Inc. - Over 5 years, raised \$1 million for the agency from the U.S. Department of Health and Human Services and the U.S. Department of Education.
