This multi-center randomized clinical trial in patients with recent-onset type 2 diabetes will compare the metabolic effects of four common anti-diabetic drugs (sulfonylurea glimepiride, the DPP-4 inhibitor sitagliptin, the GLP-1 agonist liraglutide and the basal insulin glargine) when combined with metformin. (8/2012 7/2017).
