Description: CBA as the **first** private Certified Nurse-Midwife[CNM] practice in S. Florida. I Opened CBA with two CNMs and an OBGYN physician as partners. We competed with private practice OBGYN. and delivered at two Miami area hospitals. We did not become a free-standing birth center.

Responsibility: **R.N.** in an office setting and **Administrator/Owner**. The role of **nurse-entrepreneur** was new to me. I learned to:

1. Establish a private advanced nurse practitioner business where there was no precedence; requiring knowledge of city, county, state, and professional regulation requirements as well as nurse practice state statutes.
2. Establish the ability to practice in a physician-dominated community a independent practitioners; requiring skillful negotiations with hospitals and physicians to get privileges to admit clients to hospitals.
3. Negotiate with insurance companies to become providers and receive reimbursement for services. CBA was the first CNM practice admitted to an HMO/PPO in Miami.
4. Change Florida State Statutes by political lobbying for reimbursement under managed care.
5. Manage a business requiring knowledge of insurance billing, accounting, and legal matters, along with day to day operations for ordering and payments.

After the workshop, the UM students break into rap groups with the teens. I also do focus group evaluations of the program. The UM students provide positive role models for at risk teens and act as peer counselors to maximize the impact of the experience. The UM students experience firsthand the problem of adolescent pregnancy they have studied. Sites: 9<sup>th</sup>-12<sup>th</sup> grade Turner Technical High School, COPE NORTH and SOUTH[Dade County public school for pregnant adolescents], Pierre Toussaint Haitian Community Center afterschool program, 4<sup>th</sup>-6<sup>th</sup> grade Treasure Island Elementary. **Interactive Student Teaching to At Risk Populations:** Nur 324 students implemented the *Future Images* program
